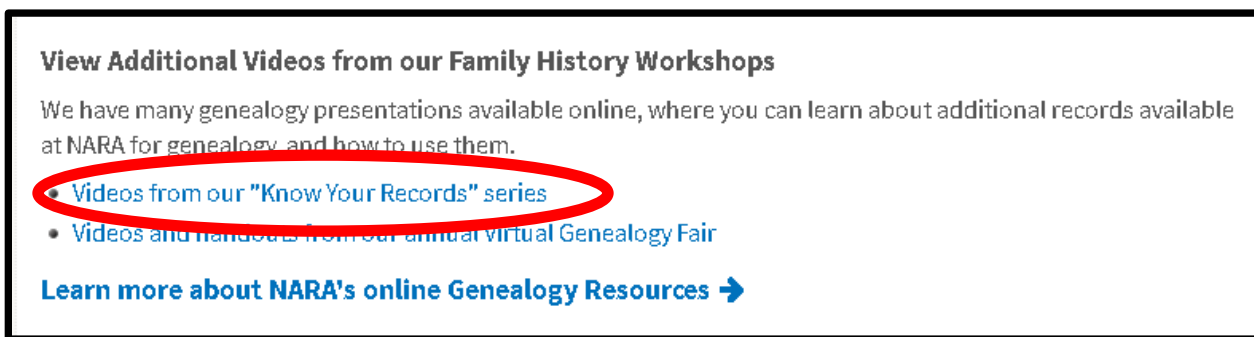


## Advance Homework for

### African American Resources Available Online at NARA

This homework is an effort to provide assistance in navigating and exploring the dense, vast, and ever-changing website of the National Archives and Records Administration (NARA). There is an abundance of tools and information to aid research, and much of it is hidden because of the sheer volume of what NARA offers.

1. Please read the handout for the class. On the second reading, please click on links to see what is being discussed and browse the linked pages.
2. Please read the webpage on [Using the National Archives Catalog](#). It is essential that people who are working to find information at NARA learn to use the catalog.
3. Register for a NARA account. Registered users will receive information about catalog updates and changes.
4. Browse the [Start Your Genealogy](#) Research page. After browsing this page to learn what tools are there, choose at least one video from the "[Know Your Records](#)" series to watch. The image below shows where to look on that webpage.



**Hint: when viewing videos, you can click on the settings icon, and change the viewing speed so the video plays faster.**

Notice that at the bottom of many of the links, such as **Know Your Records: U.S. Veterans**, is a notation View Full Playlist. When you click on that, you will see there are 15 videos in that category and will see a list on the right side of the page of all 15 sessions.



6. Using the webpage for [Appointment of Postmasters, 1832 - September 30, 1971, M841](#). Identify which roll of microfilm will have the list of postmasters for Mecklenburg County, North Carolina listed. Do you have an ancestor that was appointed as postmaster in their community?

7. Watch at least part of *The Negro Soldier*, 1944 film (running time about 41 minutes)

8. [The microfilm catalog](#) is a key tool for finding information. You do not have to have an account or sign in to use this site. This catalog can be searched to find a NARA location that has the microfilm and learn exactly which roll the information you need is on. This exercise should demonstrate some key features.

From the link above choose microfilm. In the top search box enter black. You should get a list of 21 results.

Scroll down to Publication Number M1858. You will notice from the information on this results list that this microfilm publication is from RG 94, Records of the Adjutant General's Office, 1780's-1917, and there are 5 rolls of film.

After selecting this record, look on the far right of the screen at the list of Viewing Locations to see the archives facilities that have this publication.

Under Publication Details, click on the pdf icon. The pdf will provide complete information about what is in the publication.
